The government did conduct research on the changes to UI in December 1992. This information has been released and is available to the Honourable Senators. There was further research conducted in recent weeks. The results of this most recent study have not yet been received by Employment and Immigration.

The media did report on other research done by the media and others. We do not have access to these polls and are unable to provide any further information on them.
