CANADIAN DRUG MANUFACTURERS—ASSAY OF RAW MATERIALS

Question No. 923—Mr. Herbert:

- 1. Does a Canadian drug manufacturer have to assay all imported raw materials according to specifications?
- 2. Can a drug company import a finished product from a country where regulations do not require manufacturers to do a complete assay on the raw materials?
- Hon. Monique Bégin (Minister of National Health and Welfare): 1. Canadian drug manufacturers are required to test in Canada all raw materials (domestic and imported) they use in any drug for identity, potency and purity after they receive the raw materials on their premises.
- 2. In some instances, raw materials may not be completely tested for identity, potency and purity after receipt on the premises of the foreign manufacturer. However, most countries exporting drugs to Canada have regulatory requirements roughly analogous to those in Canada. In all instances, finished products imported into Canada must be thoroughly tested in this country prior to release for sale.
