SPECIAL MEETING TOWN COUNCIL

*Large Delegation Representing Different Churches
Wait on Town Fathers and Ask For Better
Enforcement of the Scott Act.*

OTHER BUSINESS ATTENDED TO.

Town Council met in special session last night, the full board—
Mayor Miller and Aldermen Belyea,
Doyle, McMurdo, Morrison, Ritchie,
Thos. A. Russell, Chas. Sargeant
and S. A. Russell present.

A large delegation representing the Anglican, Baptist, Methodist and Presbyterian churches, the W. C. T. U., and Sons of Temperance, and private citizens waited upon the Council re the enforcement of the Canada Temperance Act.

Rev. S. J. McArthur presented, on behalf of some two hundred signers, a petition, praying for (1) A more effective enforcement of the C. T. A., and (2) that the Council consider the advisability of placing the administration of the C. T. A. in the hands of a commission.

Rev. Mr. MacArthur said that many were dissatisfied with administration of the C. T. A. in Newcastle. If majority of citizens were opposed to its enforcement, a temperance law should be sought to suit them. He advised creation of a commission of independent citizens to relieve Council of responsibility. It had been mentioned to him by several persons that in the past there had been a desire to obtain against Rev. Mr. Cuddeback. He agreed with others. Father Dax said no proof should be shown. He believed it was too much heat was being put on Newcastle. Newcastle would be better off with any liquor sold. Property values go up in value.

Rev. Dr. Burgess said he was responsible for enforcement of the Act. He did not like to see C. T. A. in effect and preferred the same person. O'Jedda, having Act checked for financial stand point. In finding a school to remove, business would improve. Newcastle was very much dragged in the mind of debauchery.

Had seen young men drink in front of his house. Was not gone on idea of commission. Council should shoulder the responsibility. Temperance people were very much in earnest. They wanted to take steps to protect society and put an end to the immoral and degrading liquor business of this town.

Rev. Mr. Nicoll demanded a far better enforcement of the C. T. Act than had been given in the past. The sale of liquor should be reduced to an absolute minimum.

Rev. W. J. Deane was not in favor of license. Scott Act was better. But, it was very largely

true that liquor was being sold freely in this town. He favored a commission.

Mrs. McLead, representing the W. C. T. U. pleaded with the Council to banish temptation to drink from the boys growing up.

H. H. Stuart, worthy patriarch of Newcastle Sons of Temperance, opposed the re-election of the enforcement of the C. T. A. to a commission.

Who was to appoint the commission? And would not some pressure be brought against the appointers of the commissioners as is now appointed to the Council itself? It was the duty of every elected body—civic, county, provincial and national—to carry out the law itself. The illegal sale of liquor should be stopped.

Mrs. Cousins demanded that Council enforce the law. They had power and should do so.

Mrs. Clarke, a school trustee, spoke along the same line as Mrs. MacLeod.

James Tracy supported demand for better enforcement. The petition indicated rising tide of indignation against liquor traffic. Council should carry out law to the latter, else they might meet some fate as has befallen the recent councillors of Montreal. No Commissioner should accept office unless prepared to do his duty.

On motion of Mr. Belyea and Rishie the petition was received, and the Council unanimously voted in favor of Section 4, demanding more effective enforcement. The council tax place was not considered.

Dr. MacArthur said he did not believe this shift of people would back the Council up to strict enforcement. He hoped things would be worse before any public opinion against Rev. Mr. Cuddeback.

Members of the delegation of the Board of Trade—E. A. McCurdy, vice pres. H. H. Stuart, secretary C. T. A., Leighton, and S. J. Cuddeback, all voted in favor of several of which Council is to be commended as far as giving in fact some measure.

On motion of Mr. Belyea and Doyle, Petition was adjourned to January 1st, Government urging the citizens to contribute to the dredging of the Miramichi to enable large vessels to come to Newcastle for coal. P. Hennessy, Hon. Alan Ross, Mayor Miller, C. E. Fish was added to this committee.

Board of Trade then withdrew. Request of Union of Canadian Municipalities for annual administration fee of \$15 was not complied with.

The Board of Works report for 1909 was received and adopted.

It showed that on account of limited appropriation only absolutely necessary work was done on streets. Repairs were promptly attended to and refuse was thoroughly cleaned up.

New sidewalks were built from Hennessy's corner along Mitchell street and through Davidson's lane to Pleasant St., from Lingley's corner to S. Miller's store, from Morrissey's corner to Miller's corner, from Mayor Miller's residence to Isaac Leighton's, from Miller Bros. store to Moody's corner. Sidewalks were built on both sides of Street's Hill.

Sewers were properly cleaned and flushed.
