

anada's presence in Mexico has grown in tandem with the relationship between the two countries and reached a scale unforeseen a generation ago. Inaugurated in 1982 by Prime Minister Pierre Elliot Trudeau, the stand-alone embassy, with its distinctive dark brown Mexican stone, has reached its capacity. Though the mission currently stands at 34 Canadian-based staff and 85 locally engaged staff, expansion this summer will see up to six more Canadians posted there with a corresponding growth in local hiring. Including contract employees, 150 people will probably be working at the embassy by 2009. Demands are particularly heavy on the Immigration Section, which deals with increasing numbers of temporary workers, and the Consular Section, whose growing client base includes both tourists and permanent or seasonal residents. Planning continues for construction of a new, larger embassy in the next few years.

Life and work in Mexico City are fast-paced and exciting. But whenever you need a little break, it's easy to slip into a local haunt, put your feet up, and enjoy an ice-cold Corona and spicy taco. And for the adventurous who are curious about local delicacies, the escamoles (ant larvae) are highly recommended.
