2. How much United States tobacco was there in bond in Canada as at the same date?
3. How many tobacco manufacturers had raw leaf tobacco in bond or storage in Canada as at the same date?
4. How much has each company?

Mr. MATTHEWS:

1. 5,366,295 standard pounds of foreign raw leaf tobacco were reported as being in manufacturers' warehouses, in Canada, on the 31st of March, 1934.
