## PARLIAMENT HILL

QUESTION AS TO PARKING SPACE FOR MEMBERS'
CARS

Since arriving here for the first session of the twentyfirst parliament I have found it most difficult to find around this building a vacant parking space for my car. Apparently the space reserved to hon. members for this purpose is insufficient. When I arrived for the eight o'clock sitting last evening I was unable to find a vacant parking space, although I drove around the building twice. I then went to the R.C.M.P. constable on duty and asked him to direct me to a space where I could park my car. He then directed me to the general parking section west of the section reserved to ministers of the crown, although parking in that section is limited to an hour and a half only.
