Inquiries of the Ministry

Mr. Knowles: Will the Prime Minister also make it clear to the C.B.C. that in our view fairness requires that this be done?

Mr. Pearson: I shall be glad to add that observation.

## DOMINION-PROVINCIAL RELATIONS

INQUIRY AS TO SPEECH BY SECRETARY OF STATE

On the orders of the day:

Mr. W. B. Nesbitt (Oxford): Mr. Speaker, may I direct a question to the right hon. Prime Minister. Would the Prime Minister clarify two points made by the Secretary of State in his speech last Wednesday to the Richelieu club of Quebec? My first question is this. When the Secretary of State said, according to Le Devoir that-

-soon the government of Quebec would benefit from 75 per cent of revenue collected in personal income taxes by the federal government—

-was he announcing government policy? Second, when the Secretary of State said, as reported in Le Devoir, and again I quote:

Mr. Lamontagne admitted, nevertheless, that there had not been up to now a serious study of the economic consequences of the independence of Quebec, and that a federal agency, under the privy council, was given the task of examining this aspect.

-may I ask is there a committee of public servants under the direction of the privy council engaged in studying the economic consequences of independence or separation of Quebec, as reported by the Secretary of State?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, this is too far reaching a question to be dealt with on orders of the day. I suggest that my hon. friend put it on the order paper or else bring it up when the estimates of the Secretary of State's department are under discussion.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, when a minister makes a statement outside the house a member is entitled to ask whether it represents government policy. That is the question that was asked.

Mr. Pearson: Mr. Speaker, if I lost sight of statement of the hon. gentleman, I apologize. Of course the minister was speaking as a member of the government on this question.

Mr. Diefenbaker: On government policy. [Mr. Pearson.]

## VETERANS AFFAIRS

PAYMENT OF ALLOWANCES TO VETERANS AND DEPENDANTS LIVING ABROAD

On the orders of the day:

Mr. H. W. Herridge (Kootenay West): Mr. Speaker, I wish to direct a question to the Minister of Veterans Affairs. Has the minister received a letter and a brief from Commander J. Leslie Harries of London, who is president of the Canadian veterans' association of the United Kingdom, urging amendments to the War Veterans Allowance Act that would make it possible for Canadian veterans living in England and their widows and orphans to receive the allowance without returning to Canada for 12 months. If so, is the government giving consideration to this request?

STUDENT LOANS-DESIGNATION OF CREDIT UNIONS UNDER ACT
