# ST. LAWRENCE RIVER-WINTER USE BY RUSSIAN SHIPS

# On the orders of the day:

Mr. J. E. Lloyd (Halifax): I have a question for the Minister of Transport. Press reports indicate that the fleet of icebreaker-ice reinforced cargo ships scheduled for winter service on the St. Lawrence river to Montreal will be augmented this winter by Russian cargo carriers. Will the minister inform the house whether the government is considering any measures to maintain and equalize the competitive position of the ports of Halifax and Saint John in view of the increasing use of Montreal as a winter port?

Hon. J. W. Pickersgill (Minister of Transport): I have heard reports that these Soviet ships are to attempt to come up the St. Lawrence during the winter time, but no exceptional steps will be taken as far as icebreaking is concerned.

Mr. Thomas M. Bell (Saint John-Albert): Will the minister give every assurance that there will be no assistance whatever to these **Russian ships**?

Mr. Pickersgill: It is possible, of course, that a ship might be in distress. Recalling some of the interventions of the hon. gentleman on previous occasions I would be very hesitant about giving any blanket undertaking of that sort. But, as I told the hon. member for Halifax, no measures which would not be taken in the ordinary normal course will be taken as a result of this attempted passage.

Mr. Lloyd: A supplementary question, Mr. Speaker. In view of the fact that Canada has a substantial investment in port facilities in Halifax and Saint John, will the impact of these developments on the revenues and investments of Canada be considered by the government?

Mr. Pickersgill: They certainly will be, Mr. Could I have an assurance that since Biggar Speaker; and, as the hon. member knows, we are conducting a very intensive study at the present moment of means of developing further the use of the ports of Halifax and Saint John.

Mr. Fisher: And Montreal.
