CONSIDERATION OF REPORT ON PENSION COMMISSION

Question No. 483-Mr. McIntosh:

- 1. With reference to the statement of the Minister of Veterans Affairs, as reported at page 2463 of Hansard, September 25, 1967, is it the intention of the minister to give the Canadian Pension Commission, which is the subject of the Wood commission inquiry, an opportunity to deal with provisions of the report before the report is tabled in the House of Commons?
- 2. If so (a) will such action permit the Canadian Pension Commission to exercise opposition to provisions of the report (b) would the minister give consideration to having the advance study referred to in his remarks of September 25 carried out by members of his staff not connected with the Canadian Pension Commission?
- 3. In the absence of the present deputy minister of veterans affairs on leave from the department, would the minister advise the house the names of departmental personnel he has selected to carry out the above study?
- Hon. Roger Teillet (Minister of Veterans Affairs): 1. It is my intention at the moment to submit the report for study by the commission and the department at an early date.
- 2. (a) Yes. I will be interested in the comments of officers of the commission as well as those of the department. (b) Members of the staff not connected with the Canadian Pension Commission will be asked to study the report.
- 3. I do not know the names of all the persons who will be asked to study the report, but it is my intention to ask the acting deputy minister and the chairman of the Canadian Pension Commission to do so, and I have no doubt they will ask members of their respective staffs to assist in this work.
