Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, if the Leader of the Opposition is interested in the facts it might be useful to say that West Indies exporters of sugar did not use the rebate fully and are not at present using fully the allocation under the international sugar agreement.

Mr. Lambert (Edmonton West): Mr. Speaker, I asked for a statement.

> SAFETY OF CANADIANS IN TRINIDAD-**EVACUATION ARRANGEMENTS**

Hon. D. S. Harkness (Calgary Centre): Mr. Speaker, may I ask a related question. Has the minister had any information on whether there has been any molestation of Canadians in Trinidad or injury to them or to their property?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, I understand that yesterday or the day before some windows were broken. There have been, however, no injuries as far as we know to any Canadians, and certainly no violence has been directed particularly against Canadian property.

Mr. Harkness: A supplementary question, Mr. Speaker. What arrangements, if any, has the minister now made for the evacuation of Canadian personnel, tourists or otherwise, from Trinidad?

Mr. Sharp: Mr. Speaker, I hesitate to give the details because I would not want to create an impression that we are expecting that evacuation will be necessary. I believe that conditions have now improved somewhat and it is important that we do not create unnecessary concern. We have contingency plans for the evacuation of Canadians.
