I have had some communication with the Prime Minister as to how we propose to proceed or might proceed in dealing with the subject matter during the present session. That discussion has not been completed yet but the matter is really under active consideration.

Mr. Forrestall: In his discussions with the right hon. gentleman, could the Government House Leader pursue the matter along the lines of separating the two anthems and not necessarily bringing in one bill dealing with both?
