Oral Questions

Actually they went out at about the same time this year as they have in the past.

COST OF ADVERTISING RESPECTING 1972 FORM

Mr. Woolliams: Mr. Speaker, a point of order.

Mr. Speaker: Order, please. I hesitate to interrupt the hon. member for Moose Jaw but the hon. member for Calgary North is rising on a point of order.

Mr. Woolliams: Mr. Speaker, with great respect, I think that ruling may have been made in a little haste.

Some hon. Members: Order!

Mr. Woolliams: Surely hon. members are prepared to hear me out. With the greatest respect, this is a very serious matter. These are difficult forms. We have seen today a misrepresentation of the facts about those forms, as has been the case for weeks. What we are looking for from the government are forthright answers on this subject. I would ask Your Honour to permit the hon. member for Calgary South to rephrase his question so that we can get some answers on this very serious matter.
