Will Mr. Richer be attending Sherbrooke University commencing September, 1981 for the next two years and, if so (a) will he receive full salary and expenses while attending university (b) will his expenses be paid by the board and, if so (i) in what amount and what is the breakdown (ii) under what authority (c) is there a home allowance expense and, if so, in what amount and what is the breakdown (d) what is the name and position of each person who approved the entire transaction and under what authority?
- 4. What is the salary range of Mr. Richer?
- 5. Is there a specific policy permitting board employees to receive full salary and expenses while attending school or university and, if so, what is the policy?
- 6. For the past three years to date, what is the name and position of each board employee who received full salary and expenses while attending school or university?

Mr. Jesse P. Flis (Parliamentary Secretary to Minister of Transport): The National Harbours Board advises as follows:

- 1. On the date of the question, Mr. J. A. J. Richer was chief, administrative and special services.
 - 2. Since April, 1975.
- 3. Yes. He will be enrolled in a co-operative program under which he will spend some time at university and some time at N.H.B.
- (a) He will receive his normal salary.

- (b) Expenses will be paid by the National Harbours Board.
- (i) according to Treasury Board travel directives for "extended periods in travel status".
- (ii) the board approved the entire transaction under the N.H.B. Act and guidelines provided by Treasury Board's personnel management manual chapter 110, sub-chapter 5 (PMM 110-5) on human resources education, training and development.
- (c) There is a home allowance expense in accordance with Treasury Board directive 8.4.1, "extended periods in travel status". The amount of the allowance will vary in accordance with Treasury Board regulations which are updated from time to time.
