MEASURE TO ABOLISH WRITS OF ASSISTANCE

Hon. Allan Lawrence (Durham-Northumberland) moved for leave to introduce Bill C-645, to abolish writs of assistance.

Some hon. Members: Explain.

Mr. Lawrence: Madam Speaker, writs of assistance are extraordinary powers which have been given for life to certain officers of both the RCMP and the Department of National Revenue under four federal statutes: the Food and Drugs Act, the Narcotic Control Act, the Customs Act and the Excise Tax Act. This bill will not only abolish the authority for the issuance of writs of assistance, but it will also abolish the use of writs of assistance.

- 2. To what extent are the operations and activities of the Parliamentary Health Unit concerning Members of Parliament and parliamentary staff supervised, co-ordinated or complemented by any government agency and are the channels and records of any such information, documentation or interpretations supplied or made accessible to other than duly-qualified physicians who are licenced provincially to practice medicine?

Are any of the data collected by or on behalf of the Parliamentary Health Unit or other parliamentary offices transmitted to the medical services of the department and, if so, for each of the past five years, do they reflect increases or decreases in the incidence of illnesses and related sick leave absenteeism and what are the relevant figures?
- 4. What disposition is ultimately made and at what point is the disposition made of forms NHW 500 completed by private doctors for their patients who are Members of Parliament or parliamentary staff and what are any statistical records or analyses compiled therefrom?
- 5. Will the government include provision in the estimates for qualified physicians to be responsible and accountable for the Parliamentary Health Unit?

March 3, 1977—Promoted to the PM 2 level as an immigration counsellor, Canada Immigration Centre, Prescott.
