## MOTIONS FOR PAPERS

Mr. Doug Lewis (Parliamentary Secretary to Deputy Prime Minister and President of the Privy Council): Mr. Speaker, I would ask that all notices of motions for production of papers on the Order Paper be allowed to stand.

Mr. Rod Murphy (Churchill): Mr. Speaker, I have a question with regard to a matter which was on the Order Paper on June 10, 1987. On page 6963 of *Hansard*, I put a motion as follows:

That a humble address be presented to Her Excellency praying that she will cause to be laid before this House a copy of the Cape Breton Development Corporation's five-year plan.

That motion was agreed to by the House. The Parliamentary Secretary to the Government House Leader indicated that the five-year plan would indeed be given to the House. What I received instead was a summary of the five-year plan. I indicated to the Government office that that was not satisfactory, that it was not what I was asking for in my motion. I would think by the very fact that the House has actually passed this motion that I am entitled, and the House is entitled, to a complete five-year plan and not an office summary.

By the way, Mr. Speaker, I have given the Parliamentary Secretary some notice of this.

Mr. Lewis: Mr. Speaker, I have investigated my hon. friend's suggestion. We are talking about terminology here. Summaries of five-year plans are customarily tabled in the House. In fact, I believe this one was tabled on May 26, 1987. It is my understanding that that is the normal practice, and that has been done.

My hon. friend has asked for something which I understand has Privy Council confidences in it. We are unable table the complete five-year corporate plan referred to by my hon. friend. I think it is a matter of terminology. I would be glad to take another look at it for my friend and see if we cannot come up with a compromise.

Mr. Murphy: Mr. Speaker, I am not going to delay matters because I realize we have a lot before the House this afternoon. However, I would ask the Speaker if this is not strictly a matter of the Parliamentary Secretary looking at what the Government may or may not wish to make public?

I would submit that by the very fact this motion has been passed by the House, which calls for a copy of the Cape Breton Development Corporation's five-year plan, that indeed this House has said it will be given to us. There is no reference to a summary. There is no reference to which items the Government wishes to give. The House has indeed spoken and that motion was agreed to.

Mr. Deputy Speaker: Shall all notices of motions stand?
