That Bill C-72 be amended in Clause 87 by striking out lines 8 to 44 at page 36 and substituting the following therefor:

"87. (1) A regulation that is proposed to be made under paragraph 38(a) prescribes any part or region of Canada for the purpose of paragraph 35(1)(a) shall be laid before Parliament at least sixty sitting days before the proposed effective date therefor.

(2) Where, within twenty-five sitting days after a proposed regulation is laid before Parliament under subsection (1), a motion for the consideration of the House to the effect that the proposed regulation not be approved, signed by no fewer than ten Members of the House of Commons, filed with the Speaker of the House, the Speaker shall, within five sitting days after the filing of the motion,
