What is the minister to do to protect the manufacturers of this country and the linguistic duality of our nation?

Hon. Harvie Andre (Minister of Regional Industrial Expansion and Minister of State for Science and Technology): Mr. Speaker, there are 3,000 Customs officers at the border performing this function of enforcing Canadian laws, as well as the inspectors.

Basically we have a law that is proper and we enforce it to the best of our ability, much the same as the police enforce speeding laws. We cannot guarantee that every single product will be properly labelled without putting in a huge number of inspectors at huge costs and putting a huge bureaucratic burden upon the very manufacturers about whose prospects he is concerned.

## **TRANSPORT**

Mr. Les Benjamin (Regina—Lumsden): Mr. Speaker, I would rather you had called Orders of the Day but I will take the question.

Mr. Speaker: I must say to the hon. member that it is very tempting. Perhaps a short question.

Mr. Benjamin: Mr. Speaker, I only get one once every two or three months, now I have five of them.

My question is for the Minister of Transport. The National Transportation Agency has served notice of its intention to remove regulations over passenger rail service in this country. This includes rescinding the declaration that VIA Rail services are passenger train services, and allowing VIA Rail to make its own decisions on routing and frequency of routes even though the royal commission appointed by the minister has not had a chance to give an interim report.

Will the minister request the National Transportation Agency not to proceed with this until the royal commission has issued an interim report and will he ensure that the eight protected routes are kept in place regardless of what the National Transportation Agency does?

Hon. Benoît Bouchard (Minister of Transport): Mr. Speaker, I think with the experience my friend has, he knows very well that the agency has decided itself to take this initiative. It is not coming from the Department of Transport.

I think it is a fair concern when he raises the question of VIA Rail services, remote services and the royal commission. Obviously we will consider the process used by the National Transportation Agency. The government will consider the proposals but he knows very well that it is the agency's own initiative and the Department of
