

Finally, and I am sure the hon. member will agree, there is the possibility of a charter issue here, the issue of free speech. Freedom of expression may cause us to question whether or not we wish to put restrictions on a communications device where an individual could, in error or perhaps in that grey area where you are not sure of the exact intent, send an unrequested facsimile transmission and thereby conceptually impair his or her freedom of expression and freedom of speech.

Having said all of that and tried my very best not to poke so many holes in this that it would collapse under its own weight, I would like to express my general support for the bill in attempting to address this problem. I would be hopeful that the matter could be sent to committee for further study of the issues I have referred to and other issues that the House and other members will likely want to raise.

Mr. Murphy: Mr. Speaker, I think if you check with the House you will find unanimous consent to consider that the hour for Private Members' Business will have expired on this one item and that we would move on to the two other items that we have for Private Members' Business at this time.
