around. Many are on vacation. Many in my riding, and I am sure this applies to other urban centres, are afraid to open their door when the enumerator knocks on the door. You can hear the television going, you can hear people talking, but because there is so much crime infiltrating our streets and our apartment buildings, they are afraid to open the door.

I recommend to this House that we look seriously at a permanent voter's list. The city of Toronto has now enumerated its voters for municipal elections via mail, and it is working quite well. I think through mail and through a permanent voters' list, we will avoid this nonsense.

I am looking at this bill to determine how serious this government is about parliamentary reform. I congratulate the member for Don Valley West for bringing this bill forward, a bill with which all individual members can agree. If we all in this Chamber right here agree that it is a good bill, let us pass it. Let us get on with it and let us do it.

If the government is going to block this bill, then the government is not serious about parliamentary reform. Regardless of what the Electoral Commission is doing and what it reports, fine, this does not take away from it. Here is a piece of legislation that a private member is bringing into help the electoral process. Let us support it. Let us not talk it out or whatever.

I again ask the people on the government side: how serious are they with parliamentary reform? If they are serious, they will support this bill, the way I heard from my colleagues in the New Democratic Party, the way I heard from the Official Opposition, the Liberal Party, and the way I have heard from some individual Conservative members.
