They indicate that since Confederation there had not been a tax on books, magazines and newspapers until as we know, this government brought in the GST on reading. They call upon Parliament to have this tax cancelled.

First is a petition from constituents from Ottawa South asking the Government of Canada to consult with the people of Canada by way of a national referendum on matters of constitutional amendment.
