PRIVATE BILLS

INTERPROVINCIAL PIPE LINE COMPANY— FIRST READING

Hon. Hartland de M. Molson presented Bill S-42, respecting Interprovincial Pipe Line Company.

Bill read first time.

Hon. Mr. Molson moved that the bill be placed on the Orders of the Day for second reading on Tuesday next.

Motion agreed to.

CANADIAN-MONTANA PIPE LINE COMPANY— FIRST READING

Hon. Donald Cameron presented Bill S-43, respecting Canadian-Montana Pipe Line Company.

Bill read first time.

Hon. Mr. Cameron moved that the bill be placed on the Orders of the Day for second reading on Tuesday next.

CRIMINAL CODE (HABEAS CORPUS)

BILL TO AMEND—AUTHORITY TO PRINT COMMITTEE PROCEEDINGS

Hon. Salter A. Hayden, Chairman of the Standing Committee on Banking and Commerce, presented the following report of the committee on Bill C-35, to amend the Criminal Code (*Habeas Corpus*):

Your committee recommends that authority be granted for the printing of 800 copies in English and 300 copies in French of its proceedings on the said bill.

BANKING AND COMMERCE COMMITTEE

FARM MACHINERY SYNDICATES CREDIT BILL

SECOND READING

The Senate resumed from yesterday the adjourned debate on the motion of **Hon. Mr. Connolly** (Ottawa West) for the second reading of Bill C-121, to provide for the extension of credit to farm machinery syndicates.

Hon. Arthur M. Pearson: Honourable senators, last evening we were treated to a fine display of knowledge by a brilliant lawyer from the City of Ottawa on some of the farming problems. It always does one's heart good to come from the country and hear a lawyer discuss such problems and explain a bill as clearly as did the Leader of the Government yesterday.
