if the sponsor of the bill would assure us that the formula for annual adjustment of salaries is the same as that used for the salaries of members of Parliament. If not, how is any difference in the formula to be explained?

Senator Nurgitz: Honourable senators, I shall undertake to make that inquiry. Since I have until tomorrow in any event, because Senator Hastings wishes to speak to the matter, I will attempt to get the answers to that question and Senator MacDonald's question. I do not have to make a long-distance call—I will call Her Excellency and check on the tennis courts, the cricket pitch and Senator MacDonald's ability to bring whomever he wishes to functions at Rideau Hall.

Hon. Roméo LeBlanc: Honourable senators, if I may, I will ask a question of the sponsor of the bill. It need not be answered immediately. I would be happy to have the information tomorrow.

What provisions are made for the Governor General's pension? I know that in the past, with the appointment of people of relatively modest means, those issues were not properly addressed. But I think that it should be when we consider that someone serving in that position does so over a fairly limited tenure, be it five or a few more years. I would be interested to know if the pension plan is in any way comparable, for example, to that of the federally appointed judges in this country, which is a generally rewarding system.

Senator Nurgitz: Honourable senators, I will look into that, together with the question by Senator Stewart, and I hope to have an answer tomorrow.

Senator Hastings: I have one further question, honourable senators. Would Senator Nurgitz ascertain whether we provide Her Excellency the Governor General with secretarial or support services during the period of her retirement?

Senator Nurgitz: I remind honourable senators that I was handed this bill while walking into the chamber today.

Senator Hastings: You did very well.

Senator Nurgitz: Someone said, "This will be quite simple."

Senator Frith: Look out!

Senator Nurgitz: I will undertake to try to get as much of that information as I can.

On motion of Senator Hastings, debate adjourned.
