Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, there have been some discussions through the usual channels and I think there may be a general disposition in the house this morning to deal with the report stage and third reading of Bill C-197, item 79 on the order paper, before calling item No. 90, Bill C-207.

Mr. Olson: If there is general disposition to deal with those two stages of Bill C-197 without debate I would appreciate Your Honour's calling them first.

When the matter is brought forward the representative from this party, the hon. member for Calgary North (Mr. Woolliams), will simply indicate the reason we are agreeing to this rather unusual procedure at this time. Apart from that, we have no objection to what is being proposed by the minister.

Mr. Stanley Knowles (Winnipeg North Centre): That will be satisfactory to us, Mr. Speaker. The hon. member for Broadview (Mr. Gilbert) was our representative on the committee and, as everyone knows, he voted for the bill. If he had not done so, the bill would not be back here.
