

SUMMARY OF EVIDENCE

in the case of


H 59727 Gunner Arthur KUNZ, 'E' Bty, 'Q' Wing, No 2 Cdn Arty Rft Unit, Canadian Army (Overseas), a soldier in the Canadian Army, placed on Active Service.

BY DIRECTION OF THE COMMANDING OFFICER, EVIDENCE IS TAKEN ON OATH.

FIRST WITNESS: C 9729 Bdr Newman, J.A., 'Q' Wing, No 2 Cdn Arty Rft Unit, Canadian Army (Overseas), being duly sworn, states:

"I am C 9729 Bdr Newman, J.A., of the Regt Police, 'Q' Wing, No 2 Cdn Arty Rft Unit. At 1700 hrs 26 Mar 45, I was IC 'Q' Wing Guard Room. H 59727 Gunner Kunz, A., whom I here recognize as the accused, a prisoner in the Guard Room, was undergoing 28 days Field Punishment. At about 1730 hrs I detailed L/Bdr Taylor to take Gunner Kunz down to get his kit. At 1800 hrs L/Bdr Taylor returned and reported that Gnr Kunz had escaped."



SECOND WITNESS: D 175682 L/Bdr Taylor, G.R., 'Q' Wing, No 2 Cdn Arty Rft Unit, Canadian Army (Overseas), being duly sworn, states:

"I am D 175682 L/Bdr Taylor, G.R., of the Regt Police of 'Q' Wing, No 2 Cdn Arty Rft Unit. At about 1745 hrs 26 Mar 45, I was detailed by Bdr Newman to take Gunner Kunz, whom I here recognize as the accused, to his hut to get his kit. I took Gunner Kunz to hut 11 in Ontario Camp where he had slept. While Kunz was collecting his kit he asked to go to the toilet. I took him to the ablution room and I stood at the door while he went to the urinal in the corner of the room. At approx 1750 hrs I saw Gunner Kunz escape through the open window next to the urinal. I immediately went out and searched the area, I could not find Gunner Kunz. I reported the escape to Bdr Newman."


The Accused declines to Cross Examine This Witness.

THIRD WITNESS: G 60775 L/Bdr Trenholme, J.C., 'Q' Wing, No 2 Cdn Arty Rft Unit, Canadian Army (Overseas), being duly sworn, states:

"I am G 60775 L/Bdr Trenholme, J.C., of the Regt Police of 'Q' Wing, No 2 Cdn Arty Rft Unit. On 20 April 1945 I was on duty in 'Q' Wing Guard Room. At 1025 hrs 20 April 45, H 59727 Gnr Kunz, A., whom I here recognize as the accused, reported to me as being Absent Without Leave. He was sober and properly dressed."
