Refelved. That it is the opinion of this Meeting, that an application should be made to the Legislature, for a further sum of Money to encourage the Agriculture of the Province for the present year, to be applied for the culture and manufacture of Flax, the raising of Field Pease, the curing of Beef and Pork, and the erecting of Oat Mills.

A Message from the Council by Mr. Hills

Mr. Speaker,

The Council have agreed to a Bill, entitled, An Act authorizing the lending a sum of Money to the Governors of Dalhouse College, and for securing the re-payment thereof; and also,

A Bill, entitled, An Act in addition to an Act, passed in the sisty eighth year of His late Majesty's reign, entitled, An Act to empower the Lieutenant Governor or Commander in Chief for the time being, to issue Treasury Notes.
