THE PATRON CONVENTION.

Finances in Good Condition—The World's Comments on Leader Haycock.

The Grand Association of Patrons resumed their session at 9 a.m. yesterday.

The session was resumed and the committee presented their reports.

The Financial Committee reported a cash balance of \$27,338.83, and recommended the organization's condition good.

The committee on the good of the order reported a favorable outlook for the interests of Patrons.

Three times Mr. J. Lockie Wilson proposed that the editorial in Saturday's World, outlining Leader Haycock's position, be officially read and a committee appointed to act thereon.

His suggestion was allowed to lie on the table, Mr. Wilson's remarks on the subject were characterized by airy persiflage and fiery invective.

JUDGE McDONALD'S FINDINGS.

The Mayor has Received the Report of the Judge.

The report of the recent investigation by Judge McDougall of the Gowanlock charges was received by the Mayor yesterday.

His Honor acquits Wallace Nesbitt, Q.C., and A. Monroe Grier of any wrongdoing.

Two of the three charges preferred were virtually withdrawn by Ex-Ald. Gowanlock.

His Honor states: "I find that all three of the charges are utterly untrue, and not sustained by a shadow of evidence in any shape or form whatever."

TO PUT QUEEN'S PARK IN ORDER.

Offer to Be Made to the Legislature—The Exhibition Grounds.

The Parks and Gardens Committee yesterday resolved to recommend the council to pay \$30,000 to the Provincial Government for improvements to the exhibition grounds.

The committee also recommended that the government be asked to allow the free use of it to the public.

The committee had a conference with the directors of the recent exhibition, and discussed the estimates for the exhibition ground.

No decision was arrived at. Sub-committees of each body will jointly visit the grounds on Saturday and report on the needed improvements.

Inhuman Treatment of a Child.

Hamilton, Ont., March 12.—In the case of Edith Lawrence, a young girl which died in the hospital last week, the jury brought in a verdict that the death was due to the inhuman treatment of the child.

The jury recommended that action be taken to punish West and his wife for their inhuman treatment.

The jury also recommended that the County Court Attorney have done nothing. The child was adopted by the Wests, and the evidence showed that the child was not properly cared for.

J. O. Wood and the Green Goods Game.

John O. Wood, dogger, 101 York-st., was up on trial at the Sessions yesterday upon a charge of stealing \$190 from Walter H. Orser on Dec. 29 last, in a small room to the rear of the store.

Orser was a green goods swindle. Orser had made arrangements with Hugh Barry, an Orillia home trader, for the purchase of the "green," and the meeting at the drug store was according to a pre-arranged plan.

Barry had an accomplice in the game who was secreted in a side room. The Crown was endeavoring to establish that Wood was the thief, and the case will be completed this morning.

Fire Escape at the Jail.

Ald. Frankland, Burns and Jolliffe were yesterday appointed a sub-committee to visit the jail and report on the need of a fire escape for the female prisoners.

For the past three years grand juries and the prison inspectors have urged this need; in fact, the law compels it, but it has not yet been effected.

The recent fire has stirred up the committee to their duty.

A Brantford Wholesale Grocery House in Financial Difficulties.

The trade was somewhat surprised yesterday on learning that W. T. Wickham & Co. of Brantford were in financial trouble.

A representative of the house called a meeting of its Toronto creditors at Davidson & Hay's warehouse, and offered them 40c on the dollar.

This was finally agreed to, and the firm will continue in business. If the Montreal creditors consent to a like offer, this will likely be known to-day.

W. T. Wickham & Co. started business in 1880, and up till the present time enjoyed good credit. The liabilities are over \$40,000, and assets \$35,000 to \$25,000.

Davidson & Hay are the largest creditors. Among other Toronto creditors are Perkins, Ince & Co., Sloan & Crowther, and Fugley & Dingman.
