#### BANK ACT AMENDMENT.

Mr. D. HENDERSON (Halton) moved for leave to introduce Bill (No. 234) to amend the Bank Act. He said: The explanation is very brief. The object of the Bill is to limit the investing power of the banks by placing it, as regards foreign securities, largely in the hands of the shareholders.

FALSE CREEK, VANCOUVER.

## Mr. EARLE asked:

1. Has the government granted a lease to Robert Kelly and Frank Burnett of certain portions of False Creek, Vancouver, known as the ' Mud Flats,' as stated in letter of Robert Kelly and Frank Burnett to the mayor and aldermen of the city of Vancouver, dated May 13, 1903, a copy of which was brought down in answer to an address of the House of Commons, dated 4th and 5th of May, 1903; the terms of said lease being stated in that letter as for ninety-nine years at a rental of \$100 per annum, to be increased to \$500 per annum, notwithstanding the resolution of the municipal council of Vancouver, protesting against such lease?
2. If a lease has not been executed, is it the

intention of the government to grant a lease; and if so, on what terms?

Quebec Promoters to hand charter to the Grand Trunk.

### To Safeguard Quebec.

Sir Wilfrid Reported to be looking after the Interests of his Constituents.

Quebec, July 28 .- Alderman George Tanguay, M.P.P., chairman of the Trans-Canada Railway Company, left for Ottawa this afternoon in response to a telegraphic message received from the Capital.

It transpires that the Trans-Canada Railway Company, realizing that their Pacific scheme is non est on account of the Dominion government adopting the Grand Trunk Pacific Railway, has offered to sell their charter to the

latter railway company.

They state that their only desire was to see a railway built from Quebec to Lake Winnipeg, through the northern section of the provinces of Quebec and Ontario, and if this is only accomplished by the scheme promoted by the Grand Trunk Railway and backed by the government, they will be absolutely content.
