Hon. Arthur Laing (Minister of Public Works): Mr. Speaker, all studies on this subject are of a confidential nature and intended for internal use only. Therefore I ask the hon. member to withdraw his motion.

Mr. Gilbert: Rather than say "transferred for debate" I will just say "transferred".

Mr. Macdonald (Rosedale): Transfer for debate.

Mr. Speaker: The motion is transferred for debate.

FEASIBILITY STUDY OF B.C. UNDERWATER PARK

Mr. Russell C. Honey (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): Mr. Speaker, I have spoken to the hon. member and have informed him that the English Hansard of February 13 erroneously quoted the minister

as stating that a feasibility study has been started by the department. In fact, what the minister said, and this was clearly stated in the French *Hansard* of that date, is that the department was studying the matter. No feasibility study has been made. Under the circumstances, I understand that the hon. member is willing to withdraw the motion.

Mr. Barnett: Mr. Speaker, I will be glad to withdraw the motion and when my spies tell me the feasibility study has been undertaken I will bring it up again.
