### NATIONAL PARKS

#### WOOD BUFFALO—REQUEST FOR STATEMENT ON CUTTING OF TIMBER

**Mr. G. W. Baldwin (Peace River):** I have a question for the Minister of Indian Affairs and Northern Development. In light of the fact that the National Parks Act prohibits the cutting of timber in a park save for dead and diseased timber for the protection of the forests in the park itself, has the minister taken note of the situation in Wood Buffalo Park and will he make a statement to this House shortly, when he gets the information, as to the number of timber licences which have been granted for operations there, the quantity of timber to be removed, and the extent to which the forest has already been stripped of timber as a result of the cutting which has gone on?

**Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development):** It is true, Mr. Speaker, that timber is being cut in Wood Buffalo park. That is only in a very small portion of the park, and these operations

provide work for approximately 100 Indians from this area. Nevertheless, we are presently negotiating with the government of Alberta to establish new limits, as far as Wood Buffalo park is concerned, which would enable us to obtain in exchange the areas where dinosaurs are still to be found, in Alberta.

### REGIONAL ECONOMIC EXPANSION

#### ARGENTIA, NFLD.—IMPLEMENTATION OF CRASH PROGRAM

**Mr. Walter C.
