Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I am not aware of the specific discussions which might have taken place between the minister and the Commissioner but this reform is one of a nature which is cooperated with completely by the RCMP. I see no cause for misunderstanding on it. It is a small unit within the minister's purview to co-ordinate findings and facts which come from various sources—the RCMP, the army and other provincial forces in Canada. It seems to me like a very sensible reform.

Mr. Woolliams: Mr. Speaker, may I ask a supplementary question. I think the Prime Minister is aware that the RCMP have looked after security. Let me put this question to him succinctly. Did the RCMP through the Commissioner or any other body involved in security agree to a separate civilian force being set up by the government in so far as security is concerned?

Mr. Trudeau: Here again I think there is a misunder-standing. This is not a separate security force as the member seems to understand. It is a small co-ordinating body to make sure that the minister and the cabinet have information collected from various sources, including the RCMP, so that the government will be better informed on the facts spread around in the various government departments. I mentioned defence, the RCMP and the various provincial government and municipal police forces. It seems to me if we did not have this type of co-ordinating body the opposition would be rightly blaming us for not co-ordinating our information.

Mr. Woolliams: Mr. Speaker, could the Prime Minister now tell us who is going to head this force in question?

Mr. Trudeau: Mr. Speaker, I just said it was not a force and therefore nobody is going to head it.

Mr. Woolliams: Who is going to head it?

Mr. Trudeau: Who is going to head the non-force, Mr. Speaker? A non-head.

Mr. Frank Howard (Skeena): Mr. Speaker, I wonder if I might direct a supplementary to the Prime Minister.
