Television Advertising

I have never been satisfied that the food and drug experts knew what they were talking about and I will say so in this House. An industry like this is too important to rest on decisions that hang fire for 18 months. I urge the minister to take an early stand on this matter, and I urge that clear direction be given to the rapeseed producers of western Canada.

Mr. Gilbert Rondeau (Shefford): Mr. Speaker, the statement which the Minister of Agriculture (Mr. Olson) has just made seems quite important, according to him. As for us, while reading it, we find it extremely vague, as it deals with assistance for the marketing of colza produced on 400,000 acres of land. Now, what we would like to know is whether the dealers or the producers are unable to produce or market the crop. As for us in eastern Canada, we maintain that the government must support the marketing of some western products and we must congratulate the minister in this regard.

After listening to this statement today, we do not know if the government wants to help the dealers or the producers. We should nevertheless congratulate the minister on his announcement. We ask him to be kind enough in the future to be clearer in his statements so that we know where we are in this House. We should then be better informed than we are now by this vague statement made by the minister.

ADVERTISING ON CHILDREN'S TELEVISION PROGRAMS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mrs. Grace MacInnis (Vancouver-Kingsway): Under Standing Order 43 I rise on an important matter of urgent and pressing necessity. With Christmas buying in full swing it is especially important that children be protected against the pressures of television advertising which frequently cause confusion between fact and fantasy and often cause children to bring pressure on their parents to buy unnecessary and unduly expensive foods and toys. I therefore wish to move, seconded by the hon. member for St. John's East (Mr. McGrath):

That the Secretary of State, through whom the CRTC reports to Parliament, take up with that body the desirability of imposing an immediate and complete ban on advertising on children's television programs for the remainder of 1971.

Mr. Speaker: Hon. members have heard the motion proposed under the terms of Standing Order 43. The motion requires unanimous consent of the House. Is there unanimous consent?
