Petro-Canada is not a price leader, it is a price follower. I have assured the Hon. Member that Petro-Canada will pass on the savings on gasoline prices when Petro-Canada receives them.

**Mr. John Parry (Kenora-Rainy River):** Mr. Speaker, from Newfoundland to northern Ontario to Vancouver Island, consumers across the country are asking the Government for relief. If the Minister is not prepared to direct Petro-Canada, will she tell the House what she will do for Canadian consumers?

**Hon. Pat Carney (Minister of Energy, Mines and Resources):** Mr. Speaker, I have already put in place a system on behalf of the Government which will ensure that savings will be passed on to consumers.

**Some Hon. Members:** Hear, hear!

**Miss Carney:** I have told the House that I am communicating with industry executives to ensure that all of that price decrease is passed on to consumers.

##### PRICE OF GASOLINE—ROLE OF OIL COMPANIES

**Mr. John R. Rodriguez (Nickel Belt):** Mr. Speaker, my question is directed to the Minister of Energy, Mines and Resources. The Minister said yesterday that prices "reflect competition in the market-place" and that the market-place will ensure that Canadian consumers benefit from falling world oil prices.

Is she aware that the Director of Investigation and Research under the Combines Investigation Act reported in July, 1984, that: "The Canadian consumer has been forced to bear the increased prices that result from anti-competitive arrangements in the marketing and refining sectors—" of the oil industry and, if so, will she now instruct Petro-Canada to break the price-fixing monopoly of the big oil companies in this country?

**Hon. Pat Carney (Minister of Energy, Mines and Resources):** Mr. Speaker, with respect, I suggest that the Hon. Member has just supported my point because the date he mentioned, July, 1984, is when the Liberal Government was in power. I agree that their energy policy was against competition and against the interest of the consumers. That is why I am telling the House that our energy policy is in the interest of consumers.

##### ROLE OF PETRO-CANADA

**Mr. John R. Rodriguez (Nickel Belt):** Mr. Speaker, since the Minister agrees with the Director of Investigation, does she not agree further with the Director of Investigation that: "Petro-Canada has a role to play in fostering more competition at the pump"? Will she ensure that such a role is now played by our national oil company so that the consumers can get the benefit of lower oil prices?
