## FREE TRADE

DAIRY PRODUCTS—TRADE AGREEMENT WITH UNITED STATES— APPARENT CONTRADICTION BETWEEN PRIME MINISTER AND MINISTER FOR INTERNATIONAL TRADE

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, my question is directed to the Deputy Prime Minister. We all know that the Prime Minister is trying to buy the by-election in Lac-Saint-Jean. Today, the Prime Minister is visiting the riding. Apparently, he went to a dairy farm and talked about the high cost of this kind of operation. I find that incredible, Mr. Speaker, because we know that dairy producers have asked the Government of Canada to intervene to restrict milk imports from the United States, and the Government refused so as not to upset the Americans.

Today, the Hon. Member for Algoma received a letter from the Minister for International Trade who refused to act on the concerns of dairy producers because of this, and I quote:

... the delicate situation this would create in the context of the process of approving the Canada-U.S. Free Trade Agreement.

Mr. Speaker, the Prime Minister told dairy producers that programs designed to help Canadian farmers would not be affected by the FTA, but this letter from the Minister for International Trade says the exact opposite.

How does the Deputy Prime Minister explain the contradiction between the Prime Minister's statements in Lac-Saint-Jean and the letter from his Minister for International Trade?

Hon. John Wise (Minister of Agriculture): Mr. Speaker, I did not detect any contradiction in what was stated by either the Prime Minister or the Minister for International Trade. Certainly there would not be any confusion or any contradiction in the minds of the 45,000 dairy farmers in this country.

We told the dairy farmers, in fact we told supply managed producers on March 16, 1986, I believe it was, that we would negotiate a bilateral trade agreement with the U.S. and preserve supply management in Canada. This is exactly what we delivered. In fact, Section 7(10) of the FTA, consistent with Article 11, sets out that agreement and that protection for not only the dairy farmers of Canada, who are supply managed, but also the supply managed commodities in the feather industry.
