for fuel in Canada; (b) the quality and probable cost of manufacture; (c) the names of companies now or at any time manufacturing; (d) and any other information in the possession of the government or any member or official thereof in regard thereto?

Hon. WM. TEMPLEMAN (Minister of In-

land Revenue):

1. (a) Yes, concerning deposits favourably situated as regards transportation and markets. It must be understood that peat is very plentiful in Canada, and naturally all deposits have not yet been seen or estimated.

(d) An official of the Mines Branch has been in Europe studying the industry there. His report is now being prepared and will be submitted to the House during the present session.

BORING FOR COAL IN PRINCE EDWARD ISLAND.

Mr. A. MARTIN asked:

1. Has the government undertaken any survey in boring for coal in Prince Edward

Island?

2. If so, (a) what progress has been made; (b) what is the report of the engineer in charge; (c) the cost of such survey, &c., and to whom paid?

Hon. WM. TEMPLEMAN (Minister of Inland Revenue):

1. Yes. Dr. Ellis studied the island with reference to possibility of finding coal in 1902, and published his results in the summary report for that year, recommending locations for bore-holes. He was also there this summer to point out the most suitable spot for the first test hole.

2. None. No boring has yet been done. The government has offered to defray a portion of the expense, but so far has not

been called upon.

VICTOR GAUDETTE, ADVOCATE, MONT-REAL.

Mr. BERGERON—by Mr. Taylor—asked:

1. Has Mr. Victor Gaudette, advocate, Montreal, been employed by any, and which, department of the government at Sorel, or elsewhere, at any time during the past two years?

2. If so, for what length of time was he employed, what were his duties, and what compensation was paid to him for his ser-

vices ?

3. Has Mr. Gaudette made any written report in respect of the matters which thus occupied his attention?

4. If so, what is the nature of the report, and will it be laid upon the table of the House ?

1. Mr. Gaudette was appointed to investigate alleged irregularities on the part of a foreman of works on Lake St. Peter.

2. His duties were as indicated, and so far two advances amounting to \$600 have

been made to him.

INSPECTION OF FRUIT AND VEGET-ABLE FACTORIES.

Is it the intention of the government to appoint inspectors in every fruit and vegetable factory in Ontario? If so, when?

Hon. SYDNEY FISHER (Minister of Agriculture). No. A sufficient number of inspectors will be maintained to see that the provisions of the Meat and Canned Foods Act, applicable to these establishments, are complied with.

PROHIBITION ZONE ON GRAND TRUNK PACIFIC RAILWAY.
