they are so healthy!" The day school is taught by Miss Aggie Prince, a popular teacher. There is one saw mill (the Shafter Mill) for the manufacture of lumber and staves. Coopering of apple barrels is carried on pretty extensively by Mr. Holmes Baker and Wm. J. Shafter, by men under their employ. The residences are neat, commodious, and present a comfortable appearance. The farmer's tools are kept housed. The roadside is not lumbered up, and the highway is in first-rate condition, and the small bridges usually so rough and uneven are all covered with earth, rendering them smooth and level. There are two blacksmith shops, kept by Mr. William Miller and Henry Grant, and the public man is growing well. Some straw hats are made to order, and almost anything to be found in a country store at Ass. J. Morse's, noted for his integrity, and by the way he is also Secretary and Treasurer of the Williamston Cheese Factory. There are regular religious services held in the school house and also a Lodge of I. O. of Good Templars. This neighborhood is noted for its good singers and possesses a well-trained choir under the able leadership of Wm. Bishop. Although a good district for the purpose, it is surprising that here culture is altogether neglected, and not a quill to be found in it. Some good hats are exchanged, made, and sold by Calvin Marshall of Port Lorne, has bought the Cornelius Bishop place and become a resident.

NORTH WILLIAMSTON runs parallel about a mile distant, and possesses most, if not all, the advantages of its neighbor. The soil is sandy. There are probably more root crops hereabouts to some small extent than in any other district. Some strawberries are picked for sale; also other berries in their season, as blueberries, raspberries and blackberries. There is good pasturage here. It has an efficient school taught by Miss Cropley; also regular religious meetings in the school house. Two shoemakers ply their trade, Mr. Jas. E. Sanford and Thomas Barreau, to the satisfaction of their customers. Very little is done in the river fishing; the salmon are scarce, and not few also make their way up. Two years ago Mr. Wilnot stocked the river above Morton's mill dam at Lawrencetown, but if the get down alive they will scarcely find their way back through the saw-dust and over the dam. The people here are not addicted to the dangerous practice of street racing, though the fond of that noble animal. The mail accommodation is twice a week through both districts to every main door, which is a great improvement on the "old post road" system when people had to travel four miles and under to a post-office to get their letters. The mail is carried by John FitzRandolph and William C. Shafter, and much to their praise, they settle nearly all the business coming under their notice in a very satisfactory way, and without the usual forms.
