Inquiries of the Ministry

Hon. Donald M. Fleming (Minister of Finance): Mr. Speaker, the answer is in the negative. Canada has not agreed to the establishment of any such fund. As a matter of fact no proposal has ever been made to us in concrete form. There were discussions of a preliminary nature last year on the proposal to establish an international development association, but these have never passed beyond the preliminary stage.

SAILS-IMPROVEMENT OF COMPETITIVE POSI-TION OF CANADIAN PRODUCERS

On the orders of the day:

Mr. L. R. Crouse (Queens-Lunenburg): Mr. Speaker, may I direct a question to the Minister of Finance. In view of the fact that finished sails enter Canada under special duties of 15 per cent British preferential and 22½ per cent most favoured nation, while Canadian sailmakers must pay on sailcloth a duty of 22½ per cent plus 25 per cent and 30 cents per pound most favoured nation, will the minister advise the house if any action is contemplated to improve the competitive position of Canadian sailmakers?

Mr. Speaker: It seems to me that this question is rather like the one with which I dealt previously. Taxation problems are properly budgetary matters. However, as has been pointed out the budget has been passed, and perhaps the minister is willing to comment upon it.

Hon. Donald M. Fleming (Minister of Finance): Mr. Speaker, this matter is within the scope of the reference to the tariff board and is before the board.

EXTERNAL AFFAIRS

U.S. INTERFERENCE WITH CANADIAN TRUCKS IN TRANSIT
