**ADMINISTRATION OF JUSTICE**

REASON FOR WITHDRAWAL OF FEDERAL COUNSEL FROM HEARING OF INDIAN LAND CLAIMS BY MR. JUSTICE MORROW—ASSISTANCE TO COUNSEL APPOINTED BY COURT

**Mr. R. Gordon L. Fairweather (Fundy-Royal):** Mr. Speaker, I should like to pursue the question originally asked by my colleague, the hon. member for Kingston and the Islands. Did the minister say that Mr. Dietrich Brand would not get help as the court appointed official to support the interests of the Department of Justice? What is the explanation for the precipitant withdrawal of the Department of Justice lawyers from this case?

**Hon. Otto E. Lang (Minister of Justice):** Mr. Speaker, I think my exact answer was that I did not see our role in that connection. I think they were my words when answering the hon. member.

**Mr. Fairweather:** But will you help?

**Mr. Lang:** Mr. Speaker, indeed, I am not aware of any request for any assistance, and as I say, I am not sure I see the exact perspective in which such a request would be made. As far as the so-called precipitate withdrawal, I indicated in the House, in answer to a question the other day that it is not a matter of our having withdrawn from the case, but simply of our having nothing more to say in the matter until the matter is ready for judgment. Accordingly, we do not see any need or point in having an agent present in court in the interim period.

DAIRYING—INCREASES IN COST OF PRODUCTION—REQUEST FOR HIGHER GRANTS

**Mr. Adrien Lambert (Bellechasse):** Mr. Speaker, I would like to put a question to the Minister of Agriculture.

In view of the constant rise in milk production costs, due to the rising cost of feed grain and other high-protein feeds, which is further tightening the cost-price squeeze, will the minister soon be authorizing any appreciable increase in grants for industrial milk production, as well as a reduction of export reserves, so that industrial milk producers can take advantage of increased revenues which might make it possible for them to continue in business?

There were many events in Alberta. Just to name a few, there was the Stampede, the Flare Square event, the dinner or lunch, and the parade. I would say that I was not personally invited to some of these events, and I did not make a great issue of it. I do know, and the hon. member recognizes this, that he was at the Flare Square ceremony because we had occasion to speak to each other there. Why he was not invited to the luncheon, to the civic luncheon or to the Stampede is something over which I have no control. I will see from whom these invitations were issued.
