INDIAN AFFAIRS

HEALTH CARE SERVICES TO JAMES BAY CREE—MOTION UNDER S.O. 43

Mr. Lorne Greenaway (Cariboo-Chilcotin): Madam Speaker, I rise under the provisions of Standing Order 43 to move a motion. It appears that the province of Quebec has reneged on the terms of the James Bay and Northern Quebec Native Claims Settlement Act resulting in 6,500 Crees of the James Bay territory being virtually without medical services since October last. The act clearly states that, in the event of inconsistency or conflict, the federal government under the terms of the Indian Act is to resume responsibility for medical care to the Cree people. No such aid has been forthcoming. A number of Cree children died last summer due to an epidemic of gastroenteritis. The recommendations of an investigating team of scientists have not been implemented and thus we can expect more deaths in the near future. Therefore I move, seconded by the hon. member for Prince George-Peace River (Mr. Oberle):

That this House instructs the chairman of the Standing Committee on Indian Affairs and Northern Development to seek immediately a reference that will enable the said standing committee to investigate this disgraceful and unacceptable situation before more children needlessly die.
