This grain in turn contributed \$6.3 billion to the balance of trade to the benefit of all of Canada. They, the undersigned, believe this is their fair contribution to the Canadian economy. Therefore, the undersigned petitioners humbly pray and call upon Parliament and the Minister of Transport (Mr. Pepin) to maintain the present statutory grain rate for grain producers and, as in duty bound, your petitioners will ever pray.

Wherefore the undersigned humbly call upon Parliament to maintain the present statutory grain Crow rate.

And as in duty bound your petitioners will ever pray.
