### HIBERNIA OILFIELD-MODE OF DEVELOPMENT

Yesterday the Minister put words in her Leader's mouth which were never uttered by him in the House of Commons. In the interests of clarity today, would the Minister explain what she meant when she said yesterday that her Government will not accept "a formal environmental impact statement until such time as Newfoundland decides the mode of development"? Is the Minister saying that the Government of Newfoundland alone and unilaterally will decide the mode of development or production for Hibernia oil?

Hon. Pat Carney (Minister of Energy, Mines and Resources): Mr. Speaker, I would have thought the Member would have risen on a real problem which is being created off Newfoundland, that is, the iceberg that is bearing down on Hibernia and threatening two rigs.

He always said that, if and when we had the report, it would be tabled. I have told the Hon. Member over and over again that I do not have a final report that is acceptable to me and to the Government of Newfoundland because the mode of development has not been decided upon.

**Miss Carney:** As I tried to explain yesterday, one does not determine an environmental impact of a development until one knows how one is going to drill for the oil.

## JOB CREATION QUERY

Mr. Brian Tobin (Humber-Port au Port-St. Barbe): Mr. Speaker, I hope you will be almost as generous with me as you have been with the Minister who again has been misleading the House, I hope inadvertently. I invite everyone, including the gentlemen of the press, to read *Hansard*.

An Hon. Member: And women.

Mr. Tobin: And the gentlewomen of the press.

Would the Minister confirm that, as part of that environmental assessment impact study, an attitudinal study conducted by Mobil indicates, based on statements that have been made by the provincial Government, that 50,000 Newfoundlanders expect to get jobs on that development? Will she tell us what the real, sober estimate is for jobs in the Hibernia development as outlined by Mobil Oil in a report that she is suppressing?

Hon. Pat Carney (Minister of Energy, Mines and Resources): Mr. Speaker, I am really astounded by the Hon. Member's question. I have said I have not received the report. Therefore, I have not read it. I do not have a report that establishes the environmental impact of the development of Hibernia on Newfoundland.

May I point out that when the Hon. Member's Party was in power, it totally excluded Newfoundland from having any say whatsoever in the development of the offshore.
