Two streets will be placed across the street at the market and the other on Upper Wyndham street—being the words, "High Court of Ontario and the Order of Foresters, and Court Guelph, No. 37, comes Their Brethren." JAMAICA EXHIBITION.—The exhibition at Kingston, Jamaica, will open in January 1891. In view of the geographical relation of the Island of Jamaica with the sea routes of Canada, and the nature and extent of the imports of the Island, the Government of Canada accept an invitation of the Government of Jamaica to participate in such exhibition, with a view of obtaining an extension of markets for the products and manufactures of Canada. Mr. Adam Brown, M. P. of Hamilton, has been appointed Honorary Commissioner to represent the country, and the Dominion Government will undertake to pay freight on all approved exhibits. Entries must be made not later than September 30th next; and the latest date at which exhibits can be sent forward from Halifax, N. S., or St. John, N. B., is the middle of December.

CITY COUNCIL
Ald. Kelly Gives an Account of His Stewardship.
THE CITY ASSESSMENT.
The regular meeting of the city council was held on Monday evening. Present—Ald. Lamprey, Hartnett, Fischer, Scroggie, Kerr, Palmer, Kelly, Taylor, Howard, Dowler, Kierfen-Goldie, Reid, Daiguan, Kennedy, Barber.
On motion of Ald. Lamprey a 1 Taylor, Ald. Howard took the chair. The minutes of the last regular meeting were read by the clerk.
It was then moved by Ald. Goldie, seconded by Ald. Dowler, that the council go into committee of the whole to hear an explanation of his conduct, as chairman of the Board of Works, from Ald. Kelly.
Ald. Goldie in a short speech, held that this courtesy was due to Ald. Kelly.
The chairman ruled the motion out of order.
Ald. Kelly replied to know on what rule he did so.
The chairman explained that it did not require a rule. The question before the council was, had the clerk recorded the minutes of the two former meetings correctly.
Ald. Kelly remarked if the chairman would show him the rule he would submit.
Acting-Mayor Howard said he had no feeling in the matter, but he was compelled to rule the motion out of order.
The minutes were then confirmed.
WANTS A CROSSING.
A communication was read from Mrs. M. Henderson, asking that a new crossing be made at the corner of Stewart street and the Eramosa road. Referred to Board of Works.
CELLAR FLOODED.
A communication was read from A. W. Gay, calling attention to the road in Woolwich street, east of St. George's church. He claims that the drain is closed up and his cellar is flooded in consequence. Attention was also called to the bad state of the sidewalk in that locality. Referred to Board of Works.
WARD SCHOOL.
Noble and others, asking that the water mains be extended on King street in order that their new house might be supplied with water.
MARKETS.
Ald. Scroggie, chairman, presented the ninth report, recommending payment of the following accounts: Mrs. Johnston, \$1; D. McDonald, \$3.63; U. Ryde, \$3; Mrs. Laurence, \$1—\$10.60.
ADOPTED.
ALD. KELLY MAKES A STATEMENT.
The chairman stated that Ald. Kelly would now be allowed to make a statement if he desired to do so.
Ald. Kelly then rose and thanked the chairman for the privilege of making a statement. He said he had two reasons for not attending the special meeting of the council on Friday, July 25. In the first place he was not well and was compelled to go home on that account. Secondly, there was not sufficient notice given to meet the council on so important a matter. He claimed that the acting mayor had no authority to call a special meeting and quoted the statutes to show that the requisition should have been addressed to the city clerk. On that ground he claimed that the proceedings were illegal. He said he did not question the right of the council to remove him from a committee if the meeting had been properly called. Whether he would take legal proceedings or not was a question. The speaker said he wished to ask two questions from two different members of the council. In the first place he wished to ask Ald. Kerr to state the amount of plank in the yard.
Ald. Kerr said he was not on his feet, and asked the chairman if it was in order for him to answer.
Ald. Howard said that he might answer the question.
Ald. Kerr thought Ald. Kelly should make his statement and then he could reply if he felt disposed.
Ald. Kelly then asked Ald. Kloepper if there had ever been any dispute in the committee or if he (Ald. Kelly) had ever done any work contrary to the directions of the committee.
Ald. Kloepper said he would answer the question after Ald. Kerr had replied to the one put to him.
The chairman stated that he would give Ald. Kelly permission to make any statement he saw fit, but he would not allow a general discussion.
Ald. Kelly stated that he asked Ald. Kerr the question which he did because he had been told that the money was all spent.
Ald. Kerr said there were 38,000 feet of two-inch pine, besides some cut in 3 and 4 feet lengths. He considered there was altogether about 4000 feet. There were 961 pieces of cedar, scantling. According to the foreman's measurement there were 14 cord of cedar blocks. He had not as yet
