**Mr. Marcel Lessard (Lake St. John):** Mr. Speaker, I should like to direct a question to the Minister of National Revenue. I am sorry but I did not advise him beforehand. Would the minister tell us if he intends to replace the two C.B.C. governors from Quebec who resigned during the summer, or if he has done so already?

**Hon. H. J. Flemming (Minister of National Revenue):** Mr. Speaker, I think this question would more properly be directed to the Secretary of State.

**Hon. G. E. Halpenny (Secretary of State):** Mr. Speaker, I thought the hon. member was addressing it to my colleague. Anyway I did not hear it and I wonder would he repeat it or place it on the order paper.

**FISHERIES****BRITISH COLUMBIA—IMPLEMENTATION OF RECOMMENDATIONS RESPECTING LICENCES**

On the orders of the day:

**Mr. Barry Mather (New Westminster):** I wish to direct a question to the Minister of Fisheries. By way of explanation, on September 28 I asked the minister if it was the government's intention to introduce legislation at this session based on the recommendations of the Sinclair report. This was under orders of the day, in respect to licence limitation in the fishing industry. The minister replied that day that no decision had been made.

My question today is, has a decision been arrived at in the last three weeks, or is it still in a state of indecision?

**Mr. Speaker:** I think the hon. member, with the last few words, rather ruled himself out. I cannot conceive at the moment that there is great urgency in obtaining the information on orders of the day.
