SALE OF PLUTONIUM TO FRANCE

- 2. What effective means are envisaged for inspection by Canada of French facilities to ensure that none of this fissionable material is shifted into weapons utilization?
- 3. How many 20 Kiloton strength atomic bombs can be produced from the amount of plutonium being sold to France by Canada?
- 4. What steps have been taken by Canada to check on the fissionable material produced by the reactor sold by Canada to India to ensure that it is not being used to produce nuclear weapons?
