Hon. Jean Chrétien (President of the Treasury Board) moved:

That this House do concur in interim supply, as follows:

That a sum not exceeding \$4,603,596,900.59 being the aggregate of:

(a) Three-twelfths of the total of all the items set forth in the Estimates for the fiscal year ending March 31, 1976, laid before the House of Commons on February 19, 1975, \$3,919,682,567.25.

(b) An additional eight-twelfths of the total amount of Agriculture Item L30, Energy, Mines and Resources Item L50, Finance Item 20 and Transport Items L75 and L100 (Schedule A) of the said Estimates, \$120,982,666.67.

(c) An additional five-twelfths of the total amount of Treasury Board Item 19 (Schedule B) of the said Estimates \$20,000,000.00.

(d) An additional three-twelfths of the total amount of Energy, Mines and Resources Items 30 and 65, Environment Item 15, Privy Council Item 5, Transport Item 40, 50 and L70 and Urban Affairs Item 10 (Schedule C) of the said Estimates, \$449,223,250.00.

(e) An additional two-twelfths of the total amount of Finance Item 5, Indian Affairs and Northern Development Item L80, National Health and Welfare Item 40, Secretary of State Item 10, Treasury Board Item 5 and Urban Affairs Item 15 (Schedule D) of the said Estimates, \$61,699,666.67.

(f) An additional one-twelfth of the total amount of Consumer and Corporate Affairs Item 30, Labour Item 1, Manpower and Immigration Item 10, Secretary of State Item 15, Supply and Services Items 1 and 15 and Veterans Affairs Item 1 (Schedule E) of the said Estimates, \$32,008,750.00.
