**Mr. Speaker:** I declare the motion lost. The next vote is on Motion No. 2. Mr. Ouellet moves:

Motion No. 2

That Bill C-83, be amended in Clause 1 by striking out lines 16 to 22 at page 1 and substituting the following therefor:

"tax,

(b) where the refund of tax is greater than three hundred dollars but less than nine hundred dollars, two hundred and fifty-five dollars plus ninety-five per cent of the amount by which the refund of taxes is greater than three hundred dollars, or,

(c) where the refund of tax is equal to or greater than nine hundred dollars, eight hundred and twenty-five dollars plus one hundred per cent of the amount by which the refund of tax is greater than nine hundred dollars;"
