### MEECH LAKE ACCORD

**Hon. Herb Gray (Leader of the Opposition):** Madam Speaker, my question is for the Deputy Prime Minister.

In recent days, the aboriginal peoples of Canada have expressed deep concern and, in fact, a deep sense of grievance, about the outcome last weekend of the First Ministers' Conference.

I understand that the Minister of Justice and other ministers met the leaders of aboriginal peoples in Ottawa yesterday. I would like the Deputy Prime Minister to tell us what was the outcome of the meeting. Has a result satisfactory to these native leaders been achieved? If not, what does the Government of Canada intend to do to respond further to the deep concerns and the deep sense of grievance of aboriginal peoples of this country as a result of the outcome of last week's constitutional conference?

**Hon. Don Mazankowski (Deputy Prime Minister, President of the Privy Council and Minister of Agriculture):** Mr. Speaker, first, I am sure the hon. Leader of the Opposition would acknowledge that the Meech Lake Accord and the document that was signed last week contain some very important provisions with respect to the aboriginal people.

Therefore, it is certainly in everyone's best interests to see that the Meech Lake Accord and the documents that have been signed by the First Ministers would be ratified as quickly as possible.

With respect to the meeting that took place yesterday, not only Senator Murray but the Minister of Justice and the Minister of Indian Affairs and Northern Development attended the meeting of Indian leaders. It was a very friendly and amicable meeting. The Indian leaders laid out their positions very clearly. The ministers listened and took cognizance of their concerns. They have undertaken to deal with each of them in a very specific way.

I can advise my hon. friend that discussions with respect to the points that were raised yesterday are ongoing at the present time.
