INSURANCE COMPANIES ACT

MEASURE TO ENACT

The House proceeded to the consideration of Bill C-28, an act respecting insurance companies and fraternal benefit societies, as reported (with amendments) from the Standing Committee on Finance.

SPEAKER'S RULING

The Acting Speaker (Mr. DeBlois): There are 59 notices of motions in amendment to Bill C-28, an act respecting insurance companies and fraternal benefit societies at report stage.

Motion No. A, standing in the name of the Minister of State for Finance will be debated and voted upon separately.
