He was born in Grey County, Meaford, Ontario, attended the public and high schools there, the University of Toronto and Osgoode Hall. He was called to the bar in 1936 and practised law in Meaford on his graduation. He served this country with the Royal Canadian Air Force from 1941 to 1945 and attained the rank of group captain. Mrs. Diane Marleau (Sudbury): Mr. Speaker, it is always an honour and a privilege to stand in the House to address some of the key issues of the day in the name of the people of Sudbury.

I have to say I fully support the motion on the floor today. This budget is an absolute disgrace. I am appalled that the government in power would use its power for political purposes the way it has and that this particular Minister of Finance, this particular government and this particular cabinet would agree to send out the kind of messages they have sent regarding the debt and the deficit. They led the Canadian people and the bond rating agencies into believing we were in an absolute crisis situation. They present a budget which does nothing more than play around with the figures. They try to make themselves look like they are doing things when they have really done nothing except cause more pain for the poorest people of our country.

The cuts they proposed were cuts that were already on the books, at least most of them. One major cut was the \$636 million deferral of payments to the poorest of the poor who receive a GST rebate. They will have to wait an additional three months for cheques to save this government \$7 million in administration fees. At the same time we have an outgoing Prime Minister who is willing to spend over \$1 million of Canadian taxpayers' money to go on a tour around the world.

It is unconscionable that a government, if it takes the issues of debt and deficit seriously, would allow the leader of its party to spend the amount of money that will be spent over the next few weeks to play with the feelings of Canadians. To pretend that it has nothing to
