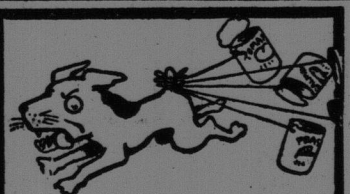

Synopsis of Canadian North-
west Land Regulations

Any person who is the sole head of
a family, or any male over 18 years old,
may homestead a quarter-section of
available Dominion land in Manitoba,
Saskatchewan or Alberta. The applic-
ant must appear in person at the Do-
minion Lands Agency or Sub-Agency
for the district. Entry by proxy may
be made at any agency, on certain
conditions, by father, mother, son,
daughter, brother or sister of intend-
ing homesteader.

Duties.—Six months' residence upon
and cultivation of the land in each of
three years. A homesteader may live
within nine miles of his homestead on
a farm of at least 50 acres solely owned
and occupied by him or by his
father, mother, son, daughter, brother
or sister.

In certain districts a homesteader in
good standing may pre-empt a quar-
ter-section alongside his homestead.
Price \$3.00 per acre. Duties.—Must re-
side six months in each of three years
from date of homestead entry (includ-
ing the time required to earn home-
stead patent) and cultivate fifty acres
extra.

A homesteader who has exhausted
his homestead rights cannot obtain
a pre-emption may take a purchased
homestead in certain districts. Price
\$3.00 per acre. Duties.—Must reside
six months in each of three years, cul-
tivate fifty acres and erect a house
worth \$250.00.

DIAMOND THIEVES

SOON CAPTURED

OTTAWA, Ont., July 22.—Two men
who gave the names of C. A. Woods,
Kingston, and F. W. Conrad, Ottawa,
were arrested shortly after midnight
last night in a Trenton hotel, on sus-
picion of being the men who stole two
trays of diamond rings from McMillan's
jewelry store here yesterday.
The Ottawa police notified all sur-
rounding towns to be on the lookout for
strangers answering description of the
robbers, and the two who arrived in
Trenton from Ottawa on the night
train were apprehended in their room
in the hotel and were brought into Ot-
tawa this morning. One of the clerks
in the jewelry store identified them as
being two of four strangers who were
in the store when rings were taken.
Both prisoners were under the influ-
ence of morphine when arrested.

Last night another member of the
quartette was discovered by Mr. Mc-
Millan and his clerk sitting in the
train which left for Toronto at eleven
o'clock. They left the train to tele-
phone the police, and while they were
away the suspect got off the train and
disappeared in the darkness.

Howard, the fourth suspect, arrested
last evening at Hull on the C. P. R.
for Winnipeg, was remanded today in
the police court for a week.

BOLT OF A FORTUNE OF
\$12,000,000 LIKELY TO BE
DISTRIBUTED IN ST. JOHN

The \$12,000,000 fortune of Robert D.
Evans seems likely to be distributed
for the most part among relatives of
his who are living in St. John. There
are in this city eight first cousins of
the Boston multi-millionaire, whose
death occurred on the sixth of the pre-
sent month.

According to the will of the wealthy
mining and rubber man, the use of
the real and personal estate goes to his
widow until the time of her death,
and thereafter descends to his heirs
and to hers, while one estimate places
the fortune at \$12,000,000, others figure
it as amounting to between \$15,000,000
and \$20,000,000.

A Sun reporter who was in conver-
sation last evening with Mrs. William
Poster of Somerset Street, North End,
learned that the closest living blood
relatives of the deceased are a group
of ten cousins of the late Mr. Evans.
The late Mr. Evans was a native of
the province. One is in Gagetown.

Mrs. Poster is connected with the
multi-millionaire through her mother,
who was a sister of his mother. Both
daughters of William Scott of this
city, through whom the following
persons are also in line for a share of
the big amount:

Robert McMurray, Wm. McMurray
and Thomas McMurray, all of St. John,
whose mother was also a sister of Mr.
Evans' mother; William Scott of New
Hampshire; Mrs. John Lundy of Brook-
field; Mrs. Melissa Finnegan of Som-
erset Street; Miss Alice McMurray of
Coburn, Mass., and Mrs. William
Flewell of Gagetown.

One child was born to Mr. Evans,
but it died before reaching maturity,
so that the cousins mentioned are his
next of kin.

ago as a boy of 12 or 13 years, he had
been in communication with Mrs. Pos-
ter.
