On motion of Sir *John A. Macdonald*, seconded by Sir *Leonard Tilley*,
Resolved, That on Wednesday next Government measures have precedence after Routine Proceedings and Questions put by Members.

Mr. *Amyot* reported from the Committee of the Whole House, to consider a certain proposed Resolution respecting the salary of an additional Puisné Judge of the Queen's Bench in the Province of *Manitoba*, a Resolution; which was read, as followeth:—

Resolved, That it is expedient that a salary of \$4,000 be provided for an additional Puisné Judge of the Queen's Bench in the Province of *Manitoba*.

The said Resolution, being read a second time, was agreed to.

Ordered, That Sir *John A. Macdonald* have leave to bring in a Bill to provide for the salary and travelling allowances of an additional Puisné Judge of the Court of Queen's Bench in the Province of *Manitoba*.

He accordingly presented the said Bill to the House, and the same was received and read the first time; and ordered to be read a second time To-morrow.

The Order of the Day being read, for resuming the adjourned Debate on the Amendment which was, on Saturday last, proposed to be made to the Question, That the Resolution (respecting subsidies to and for the parties, Railway and Railway Companies therein mentioned) be now read a second time; and which Amendment was, That the words, "but this House feels bound to express the opinion that *Canada*, when (as proposed by the said Resolution) recouping one of the Provinces "for part of the past local expenditure on Railways, should have regard to the past
